Requirements

Licencing- As a Bus Driver, you need to be able to hold / or obtain a Heavy Vehicle licence (minimum of Medium Rigid), a Drivers Authority and a Working with Children Check.

OHS – As a 'Bus Safety Worker' [as defined by the Bus Safety Act 2009 (Vic)] Bus Drivers have a direct responsibility to contribute to achievement of the required standards of an accredited bus operator by managing the risks associated with the provision of bus services.

Personal Presentation - Drivers must have a high level of personal hygiene and be well groomed.

Frequently and Regularly - Sit for extended periods (while driving a bus) and be able to meet the physical inherent requirements to drive a bus safely and meet the physical demands of rostered hours.

Occasionally - Required to stand, walk, climb or balance. Be able to load and unload luggage and lift items above head height and deploy the wheelchair ramps.

Mental Fitness - The ability to concentrate and focus for extended periods in a noisy environment (while driving a bus). Remain calm in heavy traffic conditions or if challenged by passenger behaviour. Read and understand shift boards /instructions, rosters and maps

Aptitude - Have excellent interpersonal and people skills with the ability to relate to passengers, providing high levels of customer service whilst understanding and complying with the road rules, regulations and company policies and procedures
